Project Focus — Sunset & Vine

Hooray for Hollywood! One of the brightest stars on the horizon in Hollywood is the proposed mixed use project at Sunset and Vine. Sponsored by Regent Properties, this redevelopment project will turn a 3.4 acre site into a vibrant urban community with 105,000 square feet of retail and restaurant uses, 300 units of rental housing, and a multi-level parking structure. Working closely with Regent Properties principals Doug Brown and Jeff Dinkin and land use attorney Jerry Neuman (Allen, Matkins), Craig Lawson & Co., LLC obtained the land use entitlements for the project including a complex air space subdivision, zone variances and conditional use permits. "This was a true team effort with strong support from the Los Angeles City Planning Department, the Community Redevelopment Agency and the Office of Councilmember Jackie Goldberg," said Craig Lawson & Co., LLC project manager Jim Ries. The project has been designed by MCG Architects and Thomas P. Cox Architects with survey/ civil engineering by the Mollenhauer Group and KPFF, the EIR Addendum by Christopher A. Joseph & Associates, traffic studies by Crain & Associates, and community relations by Greer/ Dailey/Minter. It is expected to break ground in early 2001.

L.A. City Planning Update

The seven Area Planning Commissions are up and running, as authorized under the new L.A. City Charter, and the appointed members represent a cross section of neighborhood activists, labor leaders, and business persons. In addition, a number of new procedures have been implemented by City staff including:

- A routing system in the City Planning Department, so that applications with more than one request (such as variance and a subdivision) are scheduled for one combined hearing.
- A new ordinance covering projects located within Specific Plan areas, including new procedures for projects that involve Exceptions or Amendments to Specific Plans (see Ordinance #173,455).
- An updated Zoning Code book is now available, including most of the new ordinances that enacted the changes made by the new City Charter. This Code book is available for purchase at the L.A. City Planning Department, or by calling (213) 580-5249.

Project Focus — Villa Venetia, Marina del Rey

When the County of Los Angeles developed Marina del Rey in the 1960s, Villa Venetia was one of the first apartment complexes to appear. Known for its spectacular location at the end of Fiji Way, adjacent to the main channel, Villa Venetia attracted tenants from all walks of life. After 40 years, however, the buildings are aging. New owners Elkor Properties (principals Brad Korzen and Greg Schem) decided to

pursue the complete redevelopment of the six (6) acre site with a 479-unit apartment project. With a design by nationally known Arquitectonica (ARQ) in conjunction with Fields Devereaux, Elkor asked Craig Lawson & Co., LLC to head up the entitlement effort. Working closely with the Department of Beaches and Harbors, the Los Angeles County Department of
